MARE(S)' OWNER COMMITMENTS:

- -To return this present contract filled and signed to Haras de Thouars.
- -The owner authorizes Haras de Thouars to practice reproductive techniques on his mare(s) and under the responsibility of the inseminators who are declared to the DRAAF and accepts the inherent risks of these techniques (Live Covering, Artificial Insemination with Fresh Semen, Artificial Insemination with frozen semen, Deep artificial insemination with frozen semen, Foaling)
- -To pay the reproductive technical fees / foaling 'fees
- -It is the Owner or his authorized representative responsibility to report any vices the mare could show and any particular features it would be good to mention in order for the Stud to take care of the mare in the best condition and without any danger.
- -If one of these obligation is not fulfilled, inseminators reserve the right to refuse the mare.
- -The signatory acknowledges to be aware that there are inherent risks with reproductive techniques in particular rectal laceration which can have fatal consequences or accidents due to contention.

RESPONSIBILITY

Any kind of services/acts provided by the inseminators have an obligation of means but not an obligation of results. The EARL HARAS DE THOUARS assumes liability of the animals entrusted. In case of accident, Stud' responsibility may be held liable only with proof of serious fault or negligence.

Professional liability insurance taken out by EARL HARAS DE THOUARS N° 161 292 022 limits value of animals entrusted to a total maximum ceiling of 30 000€ (Thirty thousand euros) per animal, expert 'estimation.

For this reason, the owner assures being aware of this situation and limits his responsibility to the total amount of 30 000€ (Thirty thousand euros) and waives and releases any suits exceeding this value. Also, the owner can take out a supplementary insurance at his own charge with his insurance company.

Mares and foals are transported to and from the Stud under the sole responsibility of their owner.

The transfer between the Stud and the Owner regarding the mare and foal responsibility occurs following unloading and stop before loading.
